Voluntary declarations jointly by the newly admitted Student and his / her Guardians

1. **We**, the undersigned, (i) student of **REGENT EDUCATION & RESEARCH FOUNDATION** (henceforth mentioned as RERF) and (ii) his / her **Guardian** hereby solemnly declare that we will abide by all the rules and regulations of RERF, which are already in force or will be framed from time to time by the College authority, as final and binding for all concerned.
2. **We** understand that RERF is a self-financing private Engineering College and hence timely payment of semester fees is of paramount importance. We agree and undertake to pay the fees in full as per the respective official Notice of the college, failing which we agree to accept any punitive measure, taken by the college authority against us.
3. **We** agree that the student, without giving any unnecessary pretext, will regularly attend the college in formal college dress, reach punctually at the starting time, attend all the classes and leave at the closing time strictly as per respective class-routine. Barring absence for Medical reasons (supported by documents), the student will achieve minimum 75% class attendance in each subject as per MAKAUT rules, failing which we agree to accept any penal measure taken by the college authority.
4. **We** understand that failure to attend classes affects the students in the following ways:-
 - (a) Difficulty in following subsequent lecture classes and Jobs in Practical classes.
 - (b) Proportionate deduction in internal marks.
 - (c) Loosing claim for Placement Assistance.
5. **We** understand that **RAGGING** in any form, i.e. even teasing and/or delivering filthy words to any student, any time, within and/or outside the college campus is strictly prohibited and a cognizable offence. As such, the student of RERF, by all means, will refrain himself from organizing / involving in any sort of **RAGGING** activity, either individually or in a group to a fellow student. We agree that the offenders under this category, is liable to be punished as per rule including even expulsion from the college.
6. **We** agree and undertake not to be involved in the following punishable activities by the student:-
 - (i) Bunking of classes, (ii) Damaging College properties, (iii) Shouting and noising, (iv) Smoking and Chewing Tobacco, (v) Consumption of Alcohol or any such intoxicating item, (vi) Involvement in any group and/or Organizational activity without due permission from the College authority.
